The UAE economy is clearly divided between two sectors: the "onshore" sector, which is dominated by local business interests and restricts foreign ownership, and the "offshore" sector.

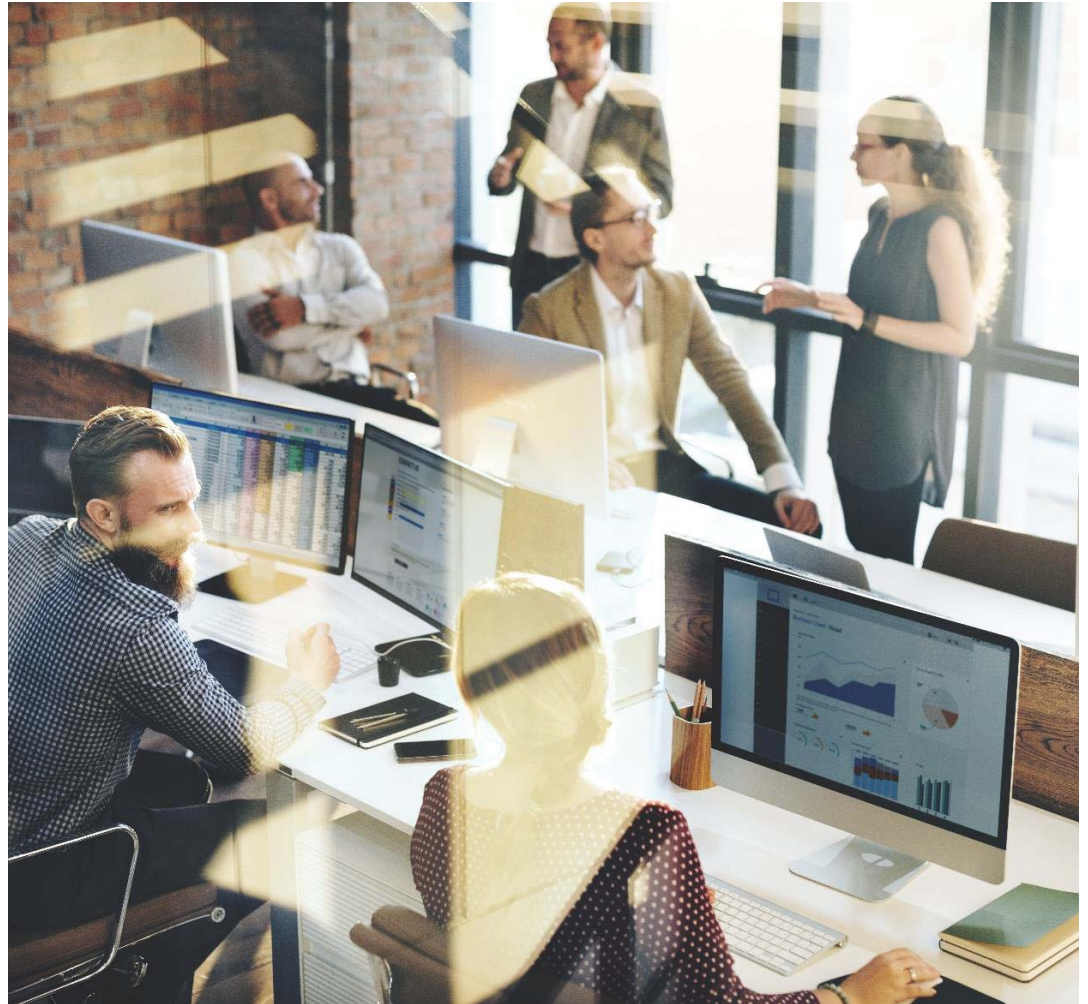
The main advantage offered by the UAE free zones is that foreign investors can retain 100% of their businesses without the need for a local partner.
